**THE HACKNEY (WAITING AND LOADING RESTRICTIONS)
(AMENDMENT NO.8) ORDER 2009**

TRO 387

1. NOTICE IS HEREBY GIVEN that on 6th February 2009 the Council of the London Borough of Hackney made the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and the Traffic Management Act 2004.
2. The general effect of the Order will be to redefine:-
 - (a) all waiting restrictions in the roads listed in Schedule 1 to this notice;
 - (b) all loading restrictions in the roads listed in Schedule 2 to this notice; and
 - (c) all motorcycle bays in the roads listed in Schedule 3 to this notice.
3. The London Borough of Hackney has deferred making a decision in regard to those roads also included in the proposal notice advertised on 12th January 2009 but not included in the Schedules to this notice.
4. Copies of the Order which will come into force on 11th February 2009, other relevant Orders and other documents giving more detailed particulars of the Order, can be inspected during normal office hours on Mondays to Fridays inclusive, until the expiration of a period of six weeks from the date on which the Order is made, in the reception area, London Borough of Hackney, 263 Mare Street, London, E8 3HT. 5. If any person wishes to question the validity of the Order, or of any provision contained therein on the grounds that it not within the powers conferred by the Road Traffic Regulation Act 1984 or that any requirement of the Act or of any instrument under the Act has not been complied with, that person may, within six weeks of the date on which the Order is made, apply for the purpose to the High Court.
