New Trader Discount Scheme

To those submitting their first street trading licence application a free trial of a single pitch for 4 consecutive single weekend days or 4 consecutive weekday trading is provided. Days must be used within the first month of trading.

Referral Credit Scheme

If a trader makes a referral for another trader to join the market and the new trader names an existing trader as having referred them, both new and existing trader will receive a credit to their account equal to a single day pitch fee.

Application to change the terms of a permanent licence (such as commodity or pitch number).	£50
Replacement Licence Card	£30

Traders Replacement Statement of Account	£10

An on-line discount of £10 will be provided for all new applications and renewals

The exception to the new temporary licence application fee are traders who have completed 4 weeks of the Kickstarter scheme at Chatsworth Rd Market who are transitioning to a Temporary Licence.
